## Scope of work

International Mine Action Standards (IMAS) set the framework and good practices for National Mine Action Authorities (NMAAs) and other relevant organisations worldwide to develop National Mine Action Standards (NMAS) and operational procedures that ensure mine action operations are safe, effective and of agreed quality. Whereas IMAS provide a framework of reference for the minimum requirements, it does not give detail on those requirements. NMAAs and mine action organisations work together to breakdown those details in their specific national and operational contexts.

The Test and Evaluation Protocols (T&EP) are documents that have been produced to support the International Mine Action Standards (IMAS) and have been approved by the IMAS Review Board. T&EP are included in relevant IMAS as the normative reference, which gives them authority within the IMAS system.

The Animal Detection Systems (ADS) expert working group was established in 2019 and tasked with the development of relevant IMAS chapters related to use of ADS in Land Release process. Upon successful completion of this task in 2020, the ADS expert working group is now looking for the external consultancy expert support for the development of the T&EP related to competencies for the ADS trainer and ADS handler respectively, to support the existing standards.

The aim of the project for which offers are requested is to support the development of the new T&EP tied to the necessary competencies for the training and use of ADS in the implementation of Land Release operations. The T&EP will be complementary to the relevant International Mine Action Standards (IMAS). The working title for the T&EP is "Competencies of the ADS trainers and handlers", subject to change.

The successful bidder will be expected to identify and list all relevant competencies for the ADS handler and ADS trainer (e.g., Mine Detection Dog trainer/handler) in the context of Mine Action. The ADS expert working group will be providing guidance and will work closely with the consultant throughout the project. The T&EP draft shall be provided in MS Word to allow easy adjustments and changes. <u>As a minimum</u>, the T&EP draft shall:

- a. define the scope of the T&EP,
- b. provide (normative and informative) references and
- c. provide a clear list of (normative) competencies for each role respectively

The consultant may be invited to some of the ADS expert working group meetings for consultations and/or to provide presentations and update on progress.

**Bidder Language** – All bids must be submitted in English. Style of writing should be the same or very similar to the existing T&EP (example can be seen here: <u>EXAMPLE</u>)

**Clarifications** - Bidders may request clarification in relation to the scope of work by submitting a written request using the bid submission email no later than 5 working days prior to the deadline date for submission.

**Minimum experience** – The bidder / the bidders' team should have minimum of ten (10) years demonstratable experience in the implementation of Land Release operations and specifically the use of ADS in the mine action context. Less experience



may be taken into consideration if sufficient proof of relevant expertise is provided. Qualifications and references of the bidder may be checked prior to offering the contract.

#### **GICHD**

The GICHD will be responsible for setting the contract timeline, terms of reference and schedule. This will be agreed upon prior to the contract award.

### **Delivery dates of the services**

The project mandate will start upon signing of the contract and will cover the period up to October 31<sup>st</sup>, 2021. The contract will require up to 15 working days. This may be adjusted depending on progress and the agreed requirements between the GICHD and the consultant(s).
