AMAT is pleased to invite consultants to submit a quotation for the provision of the description of the goods or the services described below as per requirements set out in this request for offers.

Scope of work

Established in 2019, the Ammunition Management Advisory Team (AMAT) is a joint initiative of the Geneva International Centre for Humanitarian Demining (GICHD) and the United Nations Office for Disarmament Affairs (UNODA). AMAT provides technical support to States in the safe, secure and effective management of ammunition in line with international best practice. Also, AMAT works to strengthen the capacities of States to improve the safety and security of ammunition stockpiles this contributing to a global reduction of the risks of accidental explosions and diversion.

AMAT wishes to engage an expert consultant in SMALL ARMS and LIGHT WEAPONS (SALW) MANAGEMENT. The SALW Management Consultant will lead the efforts to develop a framework for a validation system of SALW management practices, in accordance with technical guidelines in SALW management (notably the Modular Small Arms Control Implementation Compendium and other regional SALW best practices guidelines) and ISO conformity assessment methodologies (ISO series 17000).

The consultant will support a new effort to develop an internationally recognised conformity assessment system for the management of arms and ammunition. The project, which is the implementation of Phase 2 of the European Union Council Decision CFSP 2020/979, will create a framework for a conformity assessment system designed to provide stakeholders with assurances of national efforts to implement safe and secure arms and ammunition management practices. This conformity assessment is intended to serve a broader objective of supporting efforts to reduce the risks of illicit arms proliferation and accidental explosions at storage facilities. Phase 1 of the project studied the feasibility of creating an Arms and Ammunition Management Validation System (AAMVS) based on criteria set by the European Union (EU). The analysis determined that the AAMVS was feasible and that the system must be developed through a process of building international consensus. In Phase 2, AMAT will create the basic framework of the AAMVS (including the conformity assessment schemes for arms and ammunition management practices and a scheme ownership model) and a plan for developing the system.

The purpose of this mandate is to provide AMAT and its partners with expert advice on the development of an internationally recognised system of conformity assessment schemes. The consultant will support the development of critical elements of the AAMVS framework and also provide advice on the processes and direction for developing broad international support for the system.

The consultant will work closely with the Programme Manager, technical specialists, and an Expert Working Group (EWG) to establish core features of the Arms and Ammunition Management Validation System (AAMVS). The EWG will be comprised of technical experts in the field of arms and ammunition management plus national representatives in arms control and other policy experts. The Consultant will have an active role in facilitating the discussions during the EWG meetings and advising the EWG on aspects related to the development of conformity assessment systems and the implementation of the ISO/IEC 17000 series. The consultant will take a leading role in designing the features of the validation system for the SALW management component of the AAMVS. This will involve identifying, detailing and proposing options for the conformity assessment on the management of SALW. The consultant will also support technical experts in the development of the conformity assessment system. Other activities may include, depending on availability, presenting elements of the project at different international arms control events and gatherings. Travel to Geneva (ideally three or more in 2022) and internationally (once) should occur, depending on COVID restrictions.

The consultant is anticipated to spend an average of 8-10 days per month on project-related activities undertaken between 1 February 2022 – November 30 2022. Specifically, the consultant will be expected to:

1. Participate in and facilitate certain discussions during multiple Expert Working Group Meetings to collect the necessary data for the development of a conformity assessment system
2. Support technical experts in the development of the AAMVS conformity assessment, consistent with ISO/IEC 17000 series
3. Research and develop a document that outlines the best options for the validation of SALW in the AAMVS.
4. Research and analyse variations in standards and best practices between the MOSAIC and other regional SALW best practices and standards.
5. Present on technical aspects regarding conformity assessments (both generically, such as ISO/IEC 17000 series or specifically related to the AAMVS) to the EWG, the European Union, or other stakeholders.
