Scope of work

Following the adoption of the IMAS 13.10 Victim assistance in mine action in 2021 and its amendment in 2023, the GICHD intends to conduct outreach on this document. As part of general outreach on IMAS, trainings and workshops on NMAS, the GICHD wants to present the principles, requirements and recommendations for victim assistance.

See Annex A for the detailed terms of reference

Bidder Language – All bids must be submitted in English. The work shall be delivered in English.

Clarifications - Bidders may request clarification in relation to the scope of work by submitting a written request using the bid submission email no later than 5 working days prior to the deadline date for submission.

Minimum experience – The bidder / the bidders' team should have minimum of five (5) years demonstrable experience in victim assistance in the context of mine action. The experience shall include demonstrated experience in the development of standards, SOP or guidance towards victim assistance. This experience should also include experience related to the identification of victims, the identification of their needs, the identification of services, and referral processes. Less or different experience may be taken into consideration if sufficient proof of relevant expertise is provided. Qualifications and references of the bidder may be checked prior to offering the contract.

GICHD

The GICHD will be responsible for setting the contract timeline, terms of reference and schedule. This will be agreed upon prior to the contract award.

Delivery dates of the services

The service shall be delivered in full by no later than 15 December 2023.

Estimated workdays to deliver the services

It is estimated that this consultancy will take 25 working days. Consultants may choose to offer an alternative estimation with justification.

Outreach material on victim assistance in mine action

Background

Victim assistance is a pillar of mine action. The applicable definitions, principles, global requirements and recommendations are detailed in the International Mine Action Standards 13.10 Victim assistance in mine action (Hereinafter referred to as IMAS 13.10). The first edition was endorsed in 2021. It was amended in 2023.

The GICHD encourages the use of International Mine Action Standards through different activities including general outreach, trainings and workshops for the development or revision of national mine action standards. Staff from national mine action authorities and mine action organisations are the primary audiences. The main aim is to support the development of competencies towards the development of national mine action standards and standing operating procedures.

In addition, the GICHD also supports learning in different thematic areas of mine action, in particular land release and explosive ordnance risk education.

Objective and Scope

The GICHD wants to relevantly and correctly include victim assistance when disseminating knowledge.

The overall objective is to ensure that victim in mine action is relevantly included in the activities of the GICHD.

The overall objective is to prepare material that can be used by the GICHD staff to:

- Present, explain and exemplify principles, models, requirements and recommendations contained in the IMAS 13.10;
- Answer common questions concerning victim assistance in mine action;
- Support national mine action authorities in the definition of their requirements for mine action;
- Promote victim assistance in mine action in accordance with the IMAS 13.10.

In particular, the material will be used to:

- Ensure that victim assistance is included in outreach and training on International mine action standards;
- Support trainings and workshops on the development of national mine action standards;
- Support trainings and workshop on land release and explosive ordnance risk education;
- Promote the use of the IMAS 13.10.

Writing specifications

The work shall be delivered in English. Further, it shall take into account the possibility of subsequent translations. It shall be in plain English, using simple terms and avoiding long sentences and phrasal verbs.

Management of the project

The work can be performed remotely. No travel is required. The communication with the GICHD project manager can be conducted online.

Upon selection, the GICHD will organise an online meeting with the consultant during which the calendar of deliveries will be agreed.

Definition of competencies (skills, knowledge and attitude) necessary to present on IMAS 13.10.

Sessions to explain these presentations to relevant GICHD staff.

Scenario based exercises.

Description of possible illustrations, charts and any other relevant graphic material.
