The Geneva International Centre for Humanitarian Demining's Ammunition Management Advisory Team (GICHD-AMAT) is seeking to engage an **Expert Consultant in Emergency Response and Contingency Planning** to develop a comprehensive incident response package aimed at improving national responses to accidental explosions at ammunition storage sites.

The consultant will work with GICHD-AMAT to create a scalable and adaptable framework for national incident response that can be applied in diverse contexts. The consultant will also support implementation of this framework with Moldovan national and local authorities.

This consultancy will support GICHD-AMAT's efforts to reduce risks associated with accidental explosions through enhanced emergency preparedness and response systems. The work will promote coordinated, multi-stakeholder emergency response capabilities.

Scope of work

GICHD-AMAT is seeking consultancy services with extensive expertise in emergency preparedness and contingency planning, particularly in developing and implementing emergency response strategies. The consultant will also support the delivery of specialized training programmes for key national stakeholders in Moldova to enhance national capacity for emergency preparedness and response in the event of unplanned explosions at ammunition sites.

The consultant will work closely with GICHD-AMAT, national authorities, emergency response agencies, and military personnel to develop, validate, and institutionalize comprehensive contingency plans.



The consultant must demonstrate a solid technical background in emergency management, risk assessment, and contingency planning, including substantial experience in delivering training and mentoring to armed forces, emergency response agencies, or national institutions. Experience with ammunition safety incidents, explosive hazards management, and multiagency coordination is an asset. Understanding of international emergency management frameworks and experience working in diverse national contexts are highly desirable.

Expected Activities

- 1. **Design** a general framework for national incident response to accidental explosions at ammunition storage facilities.
- 2. **Develop and deliver** one (1) specialized training course on emergency planning and response for military personnel, emergency response agencies, and local authorities.
- 3. **Facilitate** stakeholder mapping and regulatory gap analyses for emergency preparedness and response systems.
- 4. **Provide** technical advice and support the development of comprehensive emergency plans, regulations, standard operating procedures, and work instructions for key stakeholders.
- 5. **Design and facilitate** one (1) tabletop exercise simulating a multi-agency emergency response to an ammunition site accident, in order to desk-test and validate emergency planning documents.
- 6. **Design a** practical exercise simulating a multi-agency emergency response to an accidental explosion at an ammunition site, to field-test and validate emergency planning documents.
