This expertise will support efforts by GICHD-AMAT to ensure the alignment of the IATG are in line with the highest of international standards. The consultant will be expected to provide trainings on AASTP-1 and AASTP-5, as well as advisory services in developing ammunition management regulations. The consultant will also review and update the IATG Module 02:20 on Quantity and Separation Distances. For the latter, the consultant will support AMAT in the preparations for the IATG Technical Review Board meeting in November 2025. The contract will continue through 2026.
