Background

The Geneva International Centre for Humanitarian Demining (GICHD) works to reduce the risks communities face from explosive ordnance, including landmines, cluster munitions, other explosive remnants of war, and ammunition storage hazards. The Centre partners with national and local authorities, donors, United Nations agencies, international organisations, NGOs, commercial actors, and academia to strengthen mine action and ammunition management efforts.

A central focus of the Centre's work has been the promotion of effective information management in mine action. Over more than two decades, the GICHD has supported the development and evolution of the Information Management System for Mine Action (IMSMA), helping actors across the sector to leverage data for informed strategic and operational decisions. The GICHD's Information Management scope of work has since grown from focusing solely on technical support into providing a comprehensive advisory service, working closely with organisations to enhance their systems and processes.

To complement these efforts and respond to the growing demand for shared learning and sector-wide knowledge exchange, the GICHD is developing a global mine action community forum. This forum will serve as a central hub for practitioners, policymakers, and stakeholders from across the mine action community to connect, collaborate, and exchange knowledge. The



forum will enable users to share best practices, pose questions, access tools and resources, and participate in discussions that strengthen information management and broader mine action practices. It will also support multilingual access, peer moderation, and long-term engagement through a user-centered, inclusive design.

This initiative aligns with the GICHD's ongoing commitment to facilitating dialogue, fostering learning, innovation, and promoting collective problem-solving across the sector.

Scope of work

The GICHD seeks to contract a consultant or company to **design**, **develop**, **and support an online community forum platform** to serve the IMSMA Core Community of Practice. The platform will function as a collaborative digital space, enabling members to share knowledge, exchange ideas, seek guidance, and engage in ongoing dialogue on information management for mine action.

The consultant/company will be responsible for delivering a **secure**, **user-friendly**, **and scalable** solution that includes the following key features and services:

- Multilingual Accessibility: Built-in AI translation functionality to allow real-time and
 automated translation of content, ensuring accessibility and engagement across diverse
 linguistic groups. These translation services must also be fully integrated with the
 platform's search functionality, enabling users to search across languages with
 consistent results.
- Advanced Search Capabilities: A fast, intuitive search system that indexes forum
 discussions, documents, and media across all supported languages. The search tool
 should support keyword relevance, filtering by tags or categories, and returning results
 across translated content.
- Moderation and Community Management Tools: Features to support Al and community moderation of content and behavior, including the ability to assign roles and permissions, flag inappropriate content, manage spam, and track user engagement and activity.
- User-Centered Interface and Design Support: A clean, responsive, and accessible
 user interface that is easy to navigate for users of varying technical proficiency. The
 consultant will also provide design customization services to align the forum's
 appearance with GICHD and IMSMA Core Community branding.
- **Hosting and Infrastructure**: Full provisioning and configuration of cloud-based hosting, ensuring high availability, data protection, and performance optimization. Hosting should be scalable to accommodate growing user numbers and usage over time.
- **Technical and Maintenance Support**: Ongoing technical support for updates, bug fixes, security monitoring, and user assistance, as well as support in implementing any feature enhancements or community-driven improvements.



The project will be executed over a **three-year period**, with the **primary development and deployment of the forum to be completed within the first 12 months**. Subsequent years will focus on maintenance, support, and incremental improvements in response to user feedback and evolving needs.

Delivery dates of the services

- Contract Start: June 2025
- Core Development Complete: May 2026
- Support & Maintenance: June 2025 May 2028 (with possibility for regular extension)

Estimated work days to deliver the services

- Year 1 (Development): ~150 days
- Year 2–3 (Support & Improvements): ~70 days (approximately 35 days per year)
- Total estimated effort: 220 days
